### EFA HOSTS ITS 2020 ORDINARY GENERAL ASSEMBLY

The Eswatini Football Association (EFA) hosted its 2020 Ordinary General Assembly (OGA) at the Happy Valley Hotel in Ezulwini. This event was implemented on Sunday, 28<sup>th</sup> June 2020 after the EFA was granted by the Government of the Kingdom of Eswatini as by that time the COVID-19 Government Regulations restricted any gathering of people more than seventy (70).

During this meeting, the EFA Executive Committee presented both the organisation's activity and financial reports to the delegates who are also the Executive Committee Members of the EFA membership. The President of the EFA Mr. Adam Mthethwa in his address to the Congress, highlighted that due to the current status of the COVID-19 pandemic; the football competitions will remain suspended as previously

decided by the Executive Committee of the EFA. "The most probable question that is encountered is that of the negativity of the wait to resume football or decide on the fate of the 2019/20 season. To this end, the Executive Committee of the EFA will in August 2020 to review the evolution of the COVID-19 pandemic and consequently advise its members and stakeholders", Mthethwa said.

The President of the EFA also highlighted on the progress of the organisation's regional football governance and management capacitation, sustained rebranding of the EFA and the financial ecosystem in the football business.

### EFA'S INFRUSTRUCTURE DEVELOPMENT PROJECTS GAINING MOMENTUM

The Eswatini Football

development in the country

construction of the EFA's
Technical Centre in
Lobamba, the King Sobhuza
II Stadium in Nhlangano
and the yet to be finalized

"Over and above the King Sobhuza II Stadium, which is now in full operation, housing the Shiselweni Regional Football Association and also providing a source revenue generation, the mini stadium and Regional Technical Centre at KaLanga, in the Lubombo Region, a FIFA Forward Project, is also complete", said the EFA President Mr. Adam Mthethwa.

The next stop in as far as the EFA's infrastructure development projects are concerned is Mkhuzweni where the football association will construct a mini-stadium and Regional Technical Centre in the northern Hhohho.

This project will not only benefit the sport but the people of Mkhuzweni and the surrounding

will get employment opportunities. "The Executive Committee has now set its sight on the implementation of the mini-stadium and Regional Technical Centre at Mkhuzweni, in the northern Hhohho, with the construction commencement scheduled for August 2020", said the EFA President, Mr. Adam Mthethwa. This FIFA Forward project is valued at over E23 Million.

#### EFA MEMBERS GENERAL ASSEMBLY RESCHEDULED

The Eswatini Football
Association (EFA) has
rescheduled its member
association's general
assemblies. This is due to
the suspension of football
competitions and activities
countrywide, with
competitions set to resume
at a later date.

"The EFA Member Associations and Leagues are hereby informed that following the suspension of football competitions and activities countrywide, the competitions set to resume at a later date until their conclusion, a situation which also saw the extension of the 2019/2020 football season, the hosting of the Ordinary General Assemblies (OGAs) or Annual General Meetings (AGMs) for the EFA Members is deferred to the end of the extended 2019/2020 football season pending the review of the COVID-19 pandemic situation in August 2020", said the EFA through a circular.

The other reason for the postponement was because it won't be possible to confirm the promotions and relegations due to the extension of the 2019/2020 football season. "The extension of the 2019/2020 football season has a substantial and statutory bearing on the promotion and relegation of football clubs. General Assembly business in a majority of EFA Members statutorily involves amongst others the confirmation of promotion and relegation; and the primary outlay of the business of the preceding football season as well as the forthcoming football season", read the circular.

The third reason was based on the financial reports to be done by the EFA members to their affiliates which won't be practical until the football season is concluded.

"The statutory reporting and accountability, expected to be discharged at the business of the general assemblies, which is principally relied upon a football season being concluded", the circular read. The other reason was based on the review meeting of the EFA Executive Committee

to be held in August. "The review meeting of the EFA Executive Committee in August 2020, which will provide a momentous direction on the discharge of the statutory and normal football business amid the persistent COVID-19 situation", the circular stated.

The last reason in the circular was on the fact that the COVID-19 situation was a force majeure. "The circumstance of the COVID-19 constitutes a situation of force majeure, and the EFA Executive Committee, in observance of the EFA Statutes, is staturily tasked with the supreme authority in the implementation of measures under its auspice. This is implemented obviously in compliance with the dictates of FIFA and associated statutory provision that relates to timelines of hosting and the business of OAGs of the EFA members are hereby accordingly waived", the circular concluded.

#### football programmes implemented on-line

Due to the outbreak of the COVID-19 pandemic that has adversely affected all industries in the world including football where the implementation of competition is still not possible, the EFA has resorted to the use of the latest technological applications in the implementation of certain programmes. In July an online Refereeing Instructors Workshop was implemented and the focus on this event was on the Amendments made on the Laws of the Game for the 2020/2021 football season.

"This workshop was a huge success as the participants benefited a lot in terms of the content that was discussed of which the very same content is expected to be shared to the referees who are currently active thus enhancing the standard of refereeing in the country", said Mr. Sifiso Zondo who is EFA's Refereeing Manager.

On another note, the EFA's Technical Director (TD) Mr. Bhekisisa Mkhonta who was also one of the participants of the Refereeing Instructors Workshop also facilitated the Coaching Instructors and Coaching Workshops using the zoom application. The main objective of the Coaching Instructors Workshop was to enhance the personality and common behavioural traits of the instructors whilst for the

Coaching Workshop was to empower the coaches on the difference between job description and job design as a coach. "These workshops were a huge success and thanks a lot to the participants as this is a sign of commitment on their part in as far as football development in the country is concerned", Mkhonta said.

Over and above these workshops, the TD participated in two on-line international football development programmes. These were the FIFA Talent Ecosystem Analysis, FIFA Grow Professionally Workshop and the CAF Convention.

The FIFA Talent Ecosystem Analysis is an on-going programme that focuses on talent identification, the FIFA Growing Professionally Workshop focused on enhancing communication skills of the TDs and the CAF Convention focused on the 8 criteria of the convention.
