EFA Ordinary General Assembly 2021 – Venue, Agenda and Candidates for the election of the EFA Executive Committee

Following the Notice of the EFA Ordinary General Assembly 2021 (*Circular No. 160*), EFA Members are reminded that the EFA Ordinary General Assembly 2021 will be held on Sunday, 27th June 2021 starting at 1000hrs (*10:00 am*) at the Happy Valley Hotel in Ezulwini.

Agenda

The agenda of the Ordinary General Assembly in conformity with Article 30 of the EFA Statutes shall be as follows:

1. Roll call
2. Verification that the notification and composition of the General Assembly comply with the provisions of the Statutes;
3. Approval of the Agenda
4. Appointment of three members to check the minutes
5. Suspension or expulsion of a member (*if applicable*)
6. Address by the President
7. Confirmation of minutes of the preceding General Assembly
8. Report of the Executive Committee presented by the Secretary General covering the period since the last General Assembly
9. Presentation of the financial statements and approval
10. Presentation of the budget and approval
11. Appointment of independent auditors (*if applicable*) upon the proposal of the Executive Committee.
12. Votes on proposals for amendments to the Statutes, the regulations governing the application of the Statutes and the standing orders of the General Assembly (*if applicable*)
13. Discussion of other proposals submitted by the members and the Executive Committee within the period stipulated under par. 1 (*if applicable*).
14. Admission of a member (*if applicable*).
15. Election of the Executive Committee (*if applicable*).

Candidates for the election of the EFA Executive Committee

This being an Elective Ordinary General Assembly of EFA; EFA members are notified that in terms of Article 35 (2) the President, two (2) Vice Presidents and two (2) members of the Executive Committee shall be elected by the General Assembly. The following candidates have been validated by the EFA Ethics Committee in observance to the EFA Electoral Code and EFA Statutes, in particular Art. 35 (6) a) to f), for the election of the Vice Presidents and Executive Committee members; and Art. 35 (6) a) to f) and Art. 41 (5) for the election of the President.

The candidates are therefore communicated in accordance with Articles 35 (8) and 41 (4) of the EFA Statutes, as hereunder tabulated:

Reminder on Delegates to the Ordinary General Assembly

Delegates' numbers shall be as enshrined in Article 24 (1) a) to e) of the EFA Statutes i.e. a maximum of six (6) delegates for Premier League of Eswatini; each of the four (4) Regional Football Associations, the Referees Association; the Coaches Association; and the Women Football Association.

Members are also expected to observe the dictates of Article 24 (2).
